CLARB Defines 'Public Welfare'

"CLARB sponsored this groundbreaking research to help the organization and its member licensure boards better understand the relationship between the licensed practice of landscape architecture and public welfare," noted CLARB Executive Director Joel Albizo, "and to ensure that it was properly recognized in the licensure examination." The committee in Toronto formed over a decade ago conducts projects which are spearheading in their Canadian context. Their work has given rise to a City policy, which links to the Green Standard, and a comprehensive guidelines document. 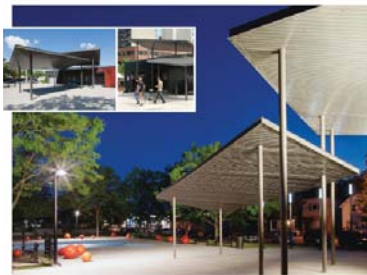


City of Ottawa Urban Design Awards
