## Special Edition Newsletter: OALA Conference and AGM

The 2011 OALA Conference and AGM saw its largest attendance in some time, with 121 Full Members registered for the AGM, and over 200 members, guests and sponsors in total participating in our day-long event at The Bram & Bluma Appel Salon at the Toronto Reference Library. The venue was beautiful. The food was delicious and everyone was engaged and energetic. Break times were noisy as old friends and new took time to catch up with each other.

## The Conference

The day started with a keynote address from Geoffrey Cape of Evergreen, who inspired participants to consider the possibilities of collaboration as seen through the model that Evergreen has followed. Evergreen has used collaboration – sometimes with unlikely partners – to strengthen the organization and help it to succeed. An excellent example of this success was shown in the redevelopment process and design of the renowned Brickworks in Toronto.

Eha Naylor took us back in time to remind us of the roots of the profession and OALA itself, and then she moved us forward to consider the competitive landscape and how it could challenge the profession in future. Eha supports pursuing legislation that will license Landscape Architects and put us on equal footing with other licensed professionals. This would offset our smaller numbers and allow our specialized skills to be sought in more appropriate instances, while also presenting a message of equivalent competency to the consumer.



From Barbados National Park to Edmonton's Jasper Avenue, Mark Reid used his own experiences to highlight the increasing importance of collaboration within and beyond the profession, and how fundamental it is to successful business operation and development. He presented collaboration as a way to expand into new markets. Mark kept the delegates grounded as he also provided an example of collaboration resulting in a stalemate, illustrating the need of Landscape Architects to maintain professional integrity throughout the process.

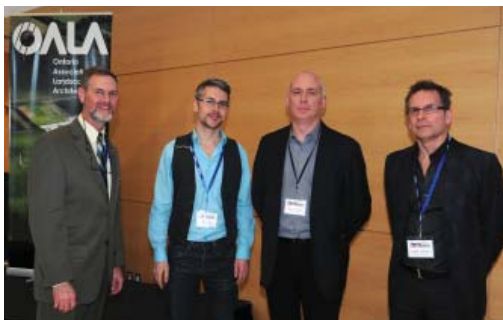
